Dear Ms. Blömker,

Thank you for your letter of 20th May 2008 enquiring into the status of ExxonMobil's plans for compliance with the pending REACH legislation.

As you are undoubtedly aware, the REACH legislation entered into force on June 1st, 2007. ExxonMobil is currently assessing the full implications of the regulation for our suppliers and our customers. In particular, the Technical Guidance documents on the operation of some aspects of REACH (e.g. SIEF and Consortia Operation, Cost Sharing, Protection of Confidential Information, Definitions of Uses etc.) are still under development under the various REACH Implementation Projects (RIPs).

While we start from the position that all of our key substances are expected to be registered, it is premature to be specific on our plans with respect to individual products until the REACH process has further developed and some of the critical REACH Implementation Projects have been completed.

One of the requirements of REACH is that information is exchanged up, down and across the supply chain. In order to minimise the administrative task associated with disseminating and consolidating this information, it is important that industry standardises on the format of any questionnaires used for this purpose and develops tools to automate this process to the maximum extent possible. Consequently, ExxonMobil is actively engaged in Industry Association activities to design and develop systems to effectively manage this exchange of information. We will provide information on our products once these tools have been developed and are available for use by industry.

ExxonMobil has the capabilities, the resources and the focus on the emerging legislation to fulfill our obligations under REACH. Specifically, we already have teams in place to develop an inventory of substances subject to registration under REACH; employees from several ExxonMobil companies are contributing to the REACH Implementation Projects through the appropriate Industry Associations and we are actively involved with these Industry Associations in all aspects of REACH implementation.
